VIII. New Business:

- Minutes summarizing topics discussed at meetings of the BOD, including any actions taken, are to be reported to all club members in the same manner and distribution as all general meeting reports. (lan)
- High / Low Speed Passes Revert Field Rules Item 6 from 7.9.22 revision changes to the version that preceded it. (Ian)
 - Ty responded to both issues stating the change in the Field Rules, item 6
 regarding passes over the runway north of the painted center line had been
 approved in 2022 during a board member meeting. The change was to be
 brought to the general membership, but no record could be found to verify the
 change was adopted by vote of the general membership.

It was acknowledged any significant changes to the Field Rules and Bylaws requires discussion and approval by the general membership based upon established procedural practice. It is believed this change had been inadvertently left off the agenda for general membership review prior to implementation.

It was agreed board member discussions affecting the general membership would be documented and available for review in webpage REPORTS section.

- Allow High / Low Speed passes over North Half of Runway. Revision of Field Rules: AIR OPERATIONS; Item 6 (Ty)
 - Vote to Approve: Majority
 - Discussion by members to perform unrestricted altitude high and low speed pass maneuvers over the north half of the runway, north of the painted centerline to avoid the wood pipe structures.
 - Slow speed passes were generally accepted as low risk as such velocities are part of normal air operations during landings and touch and goes.
 - It was recognized high speed passes had the potential of increased safety risk in case of departure from controlled flight due to inadvertent failure of the model or radio, environmental conditions or operator error.
 - Ty encouraged all members to participate as "safety officers" to ensure awareness and compliance with safety practices.
 - Adherence to safety procedure guidance is required, to include but not limited to:
 - Model must be flown north of the painted runway centerline away from the pilot / pit / spectator area.
 - Set up and departure of pass must also be performed north of the painted runway center line extension.





- Communication and awareness by all persons present on the pilot line / pit / spectator area of the runway pass.
- Pilot must exercise good judgement, skills and courtesy consistent with the safe operation of the maneuver for other airborne models / pilots and persons taxiing and, in the pits, / spectator areas. (ref. I.M.S.A.F.E. safety practice)
